

ORDINANCE NO. 2015-02

AN ORDINANCE AMENDING THE CODE OF ORDINANCES FOR THE VILLAGE OF CHERRY VALLEY, ILLINOIS, CHAPTER 70, SECTION 70-11. REGULATION OF WIDTH, LENGTH AND WEIGHT OF MOTOR VEHICLES OPERATED ON VILLAGE ROADWAYS. SUBSECTION (c)

WHEREAS, State Law has recently changed the weight limitations on roadways; and,

WHEREAS, the Code of Ordinances for the Village of Cherry Valley, Illinois, specifically Chapter 70, Section 70-11 (c) must be changed to bring Village Ordinances in compliances with the State Laws; and,

WHEREAS, in order to update the Village Ordinances regarding the regulation of width, length and weight of motor vehicles operated on village roadways it is necessary to amend Chapter 70, Section 70-11 (c) and to enact an Ordinance.

NOW, WHEREFORE, be it ordained by the President and Board of Trustees of the Village of Cherry Valley, Winnebago County, Illinois, as follows:

SECTION 1: Chapter 70, Section 70-11. Regulation of width, length and weight of motor vehicles operated on village roadways. (c) shall and hereby is amended to read as follows:

(c) The fee rates for permits under this section are as follows:

Oversize or Overweight Charges

Truck Dimensions	Fee
Over 72 feet long	\$25.00
Eight feet six inches wide to 12 feet wide	\$25.00
Over 12 feet wide	\$50.00
80,001 to 88,000 lbs.	\$25.00

88,001 to 100,000 lbs.	\$50.00
100,001 to 110,000 lbs.	\$75.00
110,001 to 120,000 lbs.	\$100.00
Greater than 120,000 lbs.	\$120 + \$10.00 for each additional 10,000 lbs.
120 days, oversize and less than 120,000 lbs.	\$150.00 per truck

SECTION 2: Except as modified herein, all other provisions of Chapter 70, Section 70-11, shall remain in full force and effect.

SECTION 3: This Ordinance shall be in full force and effect ten (10) days from and after its approval, passage and publication in pamphlet form.
