AN ORDINANCE PROVIDING FOR THE ABATEMENT OF THE DIRECT ANNUAL TAX LEVIED FOR THE YEAR 2015 TO PAY PRINCIPAL OF AND INTEREST ON THE \$960,000.00 GENERAL OBLIGATION REFUNDING ALTERNATE BONDS (WATERWORKS SYSTEM ALTERNATE REVENUE SOURCE), SERIES 2012, OF THE VILLAGE OF CHERRY VALLEY, WINNEBAGO AND BOONE COUNTIES, ILLINOIS.

WHEREAS, the Village of Cherry Valley, Winnebago and Boone Counties, Illinois (the "Village"), issued \$960,000.00 General Obligation Refunding Alternate Bonds, (Waterworks System Alternate Revenue Source), Series 2012 (the "Bonds"), pursuant to an ordinance adopted by the President and Board of Trustees of the Village (the "Corporate Authorities") on November 20, 2012, (the "Bond Ordinance"); and,

WHEREAS, the Village presently has funds available to enable the abatement of the remaining direct annual tax levied for the year 2015 to pay the remaining principal of and interest on the Bonds in the amount of \$257,200.00; and,

WHEREAS, the Village of Cherry Valley, Winnebago and Boone Counties, Illinois (the "Village"), issued \$960,000.00 General Obligation Refunding Alternate Bonds, (Waterworks System Alternate Revenue Source), Series 2012 (the "Bonds"), pursuant to an ordinance adopted by the President and Board of Trustees of the Village (the "Corporate Authorities") on November 20, 2012, (the "Bond Ordinance"); and,

NOW, WHEREFORE, be it ordained by the President and Board of Trustees of the Village of Cherry Valley, Winnebago County, Illinois, as follows:

SECTION 1: The Corporate Authorities hereby find that all of the recitals contained in the preambles to this ordinance are full, true and correct and do incorporate them into this ordinance by this reference.

SECTION 2: The Village Treasurer be, and she hereby is, authorized to deposit the amount of \$257,200.00 from the following fund(s) Water Operating Fund into the "Bond Fund", which was created pursuant to the Bond Ordinance.

SECTION 3: The direct annual tax levied pursuant to the Bond Ordinance for the year 2015 for the purpose of paying the remaining principal of and interest on the Bonds in the amount of \$257,200.00 be, and it hereby is, abated in its entirety.

SECTION 4: A certified copy of this ordinance shall be filed forthwith with the County

Clerk of the Counties of Winnebago and Boone, Illinois (the "County Clerk"), to effect the abatement of said sum.

SECTION 5: The direct annual taxes levied pursuant to the Bond Ordinance for the years 2016 through 2017, inclusive, for the purpose of paying the principal of and interest on the Bonds shall not be abated by the County Clerk and the County Clerk shall extend the same for collection on the tax books in connection with any other taxes that may be levied in said years in and by the Village for general corporate purposes of the Village.

SECTION 6: This Ordinance shall be in full force and effect from and after its adoption as provided by law.

THIS ORDINANCE SHALL BE EFFECTIVE IMMEDIATELY UPON ITS ADOPTIONS AND APPROVAL, PASSAGE, AND PUBLICATION IN PAMPHLET FORM.
