

ORDINANCE NO. 2016-10

AN ORDINANCE REPEALING AND RESERVING CHAPTER 2, "ADMINISTRATION", ARTICLE III, "OFFICERS AND EMPLOYEES", DIVISION 3, "ADMINISTRATOR", SECTION 2-171 "OFFICE CREATED; APPOINTMENT", SECTION 2-172 "DUTIES, EDUCATION AND EXPERIENCE, COMPENSATION, BOND", AND SECTION 2-173 "REMOVAL FROM OFFICE" OF THE CODE OF ORDINANCES OF THE VILLAGE OF CHERRY VALLEY, ILLINOIS

WHEREAS, the Board of Trustees for the Village of Cherry Valley, Illinois previously adopted Chapter 2, Administration, Article III, Officers and Employees, Division 3, Administrator, Section 2-171 Office Created; Appointment, Section 2-172, Duties Education and Experience, Compensation, Bond and Section 2-173 Removal from Office of the Village of Cherry Valley Code of Ordinances; and

WHEREAS, the Board of Trustees now desires to repeal in its entirety Section 2-171 Office Created; Appointment, Section 2-172, Duties Education and Experience, Compensation, Bond and Section 2-173 Removal from Office of the Village of Cherry Valley Code of Ordinances and to reserve those sections for future use.

NOW THEREFORE, be it ordained by the President and Board of Trustees for the Village of Cherry Valley, Illinois, as follows:

SECTION 1: The above recitals are incorporated herein and made part hereof.

SECTION 2: That Section 2-171 entitled, "Office Created; Appointment" is hereby repealed in its entirety and reserved for future use.

SECTION 3: That Section 2-172 entitled, "Duties Education and Experience, Compensation, Bond" is hereby repealed in its entirety and reserved for future use.

SECTION 4: That Section 2-173 entitled, "Removal from Office" is hereby repealed in its entirety and reserved for future use.

SECTION 5: Except as amended in this Ordinance, all other provisions and terms of Chapter 2 of the Code of Ordinances shall remain in full force and effect.

SECTION 6: This Ordinance shall be in full force and effect ten (10) days after its approval, passage and publication in pamphlet form.


