Gary Maitland moved to approve the minutes of November 8, 2011. Stephen Appell seconded. Motion carried by voice vote.

**TREASURER'S REPORT**

Treasurer Karen Melloch presented her excel report showing the year to date cash on hand April 30, 2012, is now estimated at \$1,894,289. She also presented the legal and TrimbleIT year to date expenditures.  
Karen Melloch said Attorney Stevens contacted Attorney Marengo in regards to making an early payment of the 2005A Water Bonds. Attorney Marengo said that there is a call feature but cannot pay these bonds early until January 1, 2015 this is per a letter dated December 7, 2011 from Attorney Jim Stevens.

**PAYMENT OF THE BILLS**

**TELECOMMUNICATION REPORT:**

Gary Maitland stated that if the board wants to eliminate or reduce the percentage of the telecommunication tax an ordinance will need to be passed in March 2012 and go into effective July 2012. The committee asked David Nord to present them with a schedule in order to comply with the Local Tax Allocation Department.

Gary Maitland moved to send to the village board to pay the Series 2004 bond principal and interest total of \$504,332.50. Stephen Appell seconded. Motion carried by voice vote. Interest \$19,332.50 - Principal \$485,000.00

Gary Maitland moved to send to the village board to pay the Series 2005B bond principal and interest total of \$286,620.00. JoAnn seconded. Motion carried by voice vote. Interest \$26,620.00 – Principal \$260,000.00

Gary Maitland moved to send to the village board to pay the Series 2005A bond principal and interest total of \$201,217.50. JoAnn Hudson seconded. Motion carried by voice vote. Interest \$56,217.50 – Principal \$145,000.00
