## Rental Fees: Cash Only

\$20.00 Cherry Valley Resident

\$40.00 Non-Resident

## Deposit: \$75.00 Cash Only

Full payment of rental and deposit fees and a completed application must be received at the time the reservation is made. Reservations are on a first-come, first-served basis.

Cancellation for return of the rental fee and deposit must be made at least fourteen (14) days prior to the date of the reservation.

The deposit must be picked up within 30 days of the rental date, or it will be forfeited.

Not-For-Profit Organizations, which are located and conduct their normal meetings within a 1.5 mile radius of the Village boundaries, shall not be charged a rental fee. However, a \$75.00 deposit fee is required.

Capacity: Pavilion: 75 people  
Gazebo: 25 people

## Rental Rules:

Renter is responsible for posting the reservation slip on the day of the event.

There will be a charge of \$100.00 for the Public Works Department to move or relocate picnic tables for events.

Renter must clean up all of the area rented. **Failure to clean up the area will result in a forfeiture of the Renter's \$75.00 deposit.**

All trash must be deposited in the trash receptacles. The Village does not provide trash bags.

Other areas, playground equipment, and other facilities are **NOT** included in the rental and are open to the public.

Park Rules: Hours: Daylight to Dusk

All park rules shall apply to the use of the Pavilion and Gazebo areas.

No parking or driving on the grass or walking path is permitted, even to unload or deliver food or furnishings.

Consumption of alcohol is prohibited.

No swimming or wading in, or boating on the lake is allowed.

No camping or open fires are permitted; fires are permitted in designated areas.

No tents are allowed unless approved by the Public Works Director.

If driving stakes into the ground is required for various activities, the Renter must consult with the Public Works Department first to obtain permission so that utility locations can be requested.

## OTHER AREAS TO ENJOY

Baseball Field: When the baseball field is **not reserved** for Little League or softball leagues, it can be rented on a first-come, first-served basis, weather permitting. Please contact the Cherry Valley Village Hall, 815-332-3441, for fees.

Playground: Located in the upper park area.

Tennis Courts: Located in the upper park area.

Bike Path: 1.25 miles, including a complete trip around the lake.

Lake Area: 22 acres with a depth of 10 to 22 feet.

Fishing in the Lake is regulated by the Illinois Department of Natural Resources. A State license is necessary to fish in the lake.

Fishing Harvest Restrictions are posted at the lake and are subject to change per Illinois DNR catch limits.

The use of set lines or unattended lines is prohibited. No live bait, except worms, can be used.

**Ice Fishing is prohibited on the lake.**
