

**VILLAGE BOARD OF TRUSTEES MEETING
MAY 4, 2010**

THE VILLAGE BOARD OF TRUSTEES OF CHERRY VALLEY, ILLINOIS, WINNEBAGO AND BOONE COUNTIES, CONVENED IN REGULAR SESSION ON THE 4TH DAY OF MAY 2010.

PRESIDENT JIM E. CLAEYSSSEN CALLED THE MEETING TO ORDER AT 7:00 P.M. AND LED THE PLEDGE OF ALLEGIANCE. ROLL CALL WAS TAKEN BY VILLAGE CLERK, NANCY L. BELT

President Jim Claeysen entertained a motion to adopt the agenda adding the Treasurer's April Report. James Coppernoll moved that the village board adopt agenda as presented. Sally Hollembeak seconded. Motion carried by voice vote.

President Jim Claeysen entertained a motion to approve the April 20, 2010 village board minutes. Gary Maitland moved that the village board approve the April 20, 2010 village board minutes. Scott Kramer seconded. Motion carried by voice vote.

President Jim Claeysen entertained a motion to place the April treasurer's report on file. Sally Hollembeak moved that the April 2010 treasurer's report be placed on file as presented by Treasurer, Karen Melloch. Gary Maitland seconded. A roll call vote was taken.

Treasurer, Karen Melloch stated that the cash on hand was estimated at \$766,200 and per the final report as of April 30, 2010 the cash on hand is \$899,284 a difference of \$113,084.

CITIZENS VOICE

President Claeysen asked Mrs. Bonne Whitmer to please address the village board. Mrs. Whitmer questioned the village boards' decision on budgeting for the annual fireworks expenditure, transferring interest funds from general capital improvements into the general fund, lost of telecommunication revenues. President Claeysen informed Mrs. Whitmer that the fireworks expenditure is paid through tourism funds derived from hotel/motel tax and those revenues can only be used for advertising and promoting the village, and can not be transferred into the general fund. The capital improvement interest is general fund monies and by law can be used for general fund expenditures. The telecommunication tax revenues in version six of the tentative budget was only an estimated figure, the village has only received its first allocation for the month of March, it is impossible to project what the amount of revenues the village will receive. President Claeysen thanked Mrs. Whitmer for attending the meeting.

PRESIDENT'S REPORT

President Jim Claeysen entertained a motion to approve Kegel's Motorcycle, Co. one day liquor application for their annual "Biker Jam Event" to be held June 11, 2010. Stephen Appell moved that the village board authorize President Jim Claeysen to sign the one day liquor license permit for Kegel's Motorcycle, Co., Biker Jam Event. Gary Maitland seconded. A roll vote was taken.

President Jim Claeysen entertained a motion to proclaim May 3 – 7, 2010 as Municipal Clerks Week, and extend appreciation to our Municipal Clerk, Nancy Belt and to all Municipal Clerks for the vital services they perform and their exemplary dedication to the communities they represent.
